### **Northbrooks Residents Parking Scheme**

#### **Summary**

#### Sample

Around one fifth of all households from Northbrooks responded to the survey sent to them on 4 November 2015 and the closing date for the survey was 4 December 2015.

Those household who responded declared ownership of a total of 91 vehicles around a third of which are parked on garages or driveways and half are parked on the road.

Those household who responded did not declare ownership of vehicles across Northbrooks but still responded to express their opinion.

#### Methodology

The survey was delivered to 380 households with the option to respond online or by post. Eight responses were received online and 75 by post, giving a total of 83 responses, this equates to a response rate of 21.84 per cent.

Respondents were asked to answer thirteen questions:

- 1) The number of vehicles registered at the household
- 2) The number of those vehicles parked off street
- 3) The number of those vehicles parked on street that abuts Northbrooks / Sharpecroft
- 4) To what extent do you agree or disagree with the proposal to cease operating a permit zone in Northbrooks
- 5) To what extent do you agree or disagree with the fee applied to the first car
- 6) To what extent do you agree or disagree with the fee applied to the second car
- 7) To what extent do you agree or disagree with visitors daily permit fee
- 8) What is your view on the possibility of re-introducing an annual visitors permit
- 9) What is your view on the possibility of extending permit zone times
- 10) During which periods do you find difficult to park
- 11) Their preference on the parking scheme
- 12) Preference on a public meeting
- 13) Any other comments

#### **Results Summary**

The majority of households in Northbrooks (50.6 per cent) are in favour of not ceasing the permit zone in Northbrooks.

The majority of households (53 per cent) are not in favour to the fee applied to the first car.

The majority of households (52.9 per cent) are not in favour to the fee applied to the second car.

The majority of households (65.4 per cent) are not in favour to the visitors daily permit fee.

The majority of households (74.4 per cent) are in favour to the possibility of reintroducing an annual visitors permit.

The majority of households (59.7 per cent) are not in favour to the possibility of extending permit zone times.

The majority of households (47.7 per cent) stated the find the most difficult period to park is in the evening.

The majority of household (49.3 per cent) stated their preference would be to reintroduce yearly residents permits.


The majority of household (60.7 per cent) stated they would prefer to attend a public meeting on the evening and 52.3 per cent stated Tuesday as the preferred day.


#### Other issues / concerns

Several respondents mentioned they are unhappy about the parking permits and residents should not pay to park outside their own homes as well as mentioning the permit is too expensive (some mention the cost should be lower) or are unhappy about the fee increase of the permits.

A number of respondents also expressed that they are unhappy about the cost or having pay for visitors permits especially if they are family visitors. Some expressed rise of visitors permit is not acceptable.


The maps below highlights the roads within the residents of Northbrooks - a copy was provided to all respondents.





### Q1 Please state the number of vehicles that are registered at this address


The majority of respondents (61 per cent) stated that there was one vehicle registered at their address. The second highest level of response (20 per cent) stated there were two vehicles registered at their address. 12 (15%) respondents was no vehicles, 2 respondents (2.5%) stated there were three vehicles and a further 1 respondents (1.3%) stated 4 vehicles were registered at their address.

## Q2 Are any of these vehicles parked 'off street' e.g. on a driveway or in a garage?


Twenty-five respondents (34.7 per cent) stated that they park some or all of their vehicles registered at their address off street e.g. on a driveway or in a garage.



## Q3 Are any of these vehicles parked 'on street' that abuts Northbrooks / Sharpecroft?


Thirty-seven respondents (52.1 per cent) stated that they park some or all of the vehicles registered at their address that abuts Northbrooks / Sharpecroft.







The majority of respondents (53 per cent) disagreed to the fee applied to the first car, 22 (27.1 per cent) agreed with the fee.









Twelve (16 per cent) preferred to extend the operational hours to Sunday, whereas 4 (5.3%) preferred to extend the operating hours Monday to Saturday. 




