 - (a) "the 2007 Regulations" means the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;
 - (b) "The 2022 Regulations" Means the Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022.
- 2. The following definition in Article 3 of the 2019 Order listed in this Notice as Article 2(a), shall be replaced by the following definition in Article 2(b) of this Notice:
 - (a) "penalty charge notice" has the same meaning given by Regulation 8(1) of the 2007 Regulations;
 - (b) "Penalty Charge Notice" means a notice described in Section 78 of the 2004 Act having effect as if issued or served by a Civil Enforcement Officer or posted by the enforcement authority under any regulations for the time being in force under Section 78 of the 2004 Act.
- 3. The following provisions in Article 109 of the 2019 Order listed in this Notice as Article 3(a), shall be replaced by the following provisions in Article 3(b) of this Notice:
 - (a) The Penalty Charge shall be payable not later than 16.00 hours on the Applicable Date subject to the provisions of the Penalty Charge and the 2007 Regulations;
 - (b) The Penalty Charge shall be payable not later than 16.00 hours on the Applicable Date subject to the provisions of the Penalty Charge and the 2022 Regulations.
