

**The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.35) Order 202\***

**Notice is hereby given** Colchester Borough Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 31 March 2011 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984.

**The effect of the Order:** This Order will be incorporated into The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 'the 2019 Order' by:

1. The following definition in Article 3 of the 2019 Order listed in this Notice as Article 1(a), shall be replaced by the following definition in Article 1(b) of this Notice:
  - (a) "the 2007 Regulations" means the Civil Enforcement of Parking Contraventions (England) General Regulations 2007;
  - (b) "The 2022 Regulations" Means the Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022.
2. The following definition in Article 3 of the 2019 Order listed in this Notice as Article 2(a), shall be replaced by the following definition in Article 2(b) of this Notice:
  - (a) "penalty charge notice" has the same meaning given by Regulation 8(1) of the 2007 Regulations;
  - (b) "Penalty Charge Notice" means a notice described in Section 78 of the 2004 Act having effect as if issued or served by a Civil Enforcement Officer or posted by the enforcement authority under any regulations for the time being in force under Section 78 of the 2004 Act.
3. The following provisions in Article 109 of the 2019 Order listed in this Notice as Article 3(a), shall be replaced by the following provisions in Article 3(b) of this Notice:
  - (a) The Penalty Charge shall be payable not later than 16.00 hours on the Applicable Date subject to the provisions of the Penalty Charge and the 2007 Regulations;
  - (b) The Penalty Charge shall be payable not later than 16.00 hours on the Applicable Date subject to the provisions of the Penalty Charge and the 2022 Regulations.
