
Statement of Reasons


All restrictions are proposed to avoid danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

To facilitate the passage on the road or any other road of any class of traffic (including pedestrians).

No stopping between 8am to 9am and 3pm and 4pm Monday to Friday (single red line) restrictions are proposed near to school entrances. This is to ensure sight lines near the entrances during the usual school day start and finish times when it is not considered appropriate for any vehicles to be parked and there is an increased risk to pedestrian traffic.

No stopping at any time restrictions (double red lines) are proposed around and near the junction of Westfield (near numbers 8 & 30) and Tripton road. The restrictions are proposed to ensure sight lines remain clear where parked vehicles could cause inconvenience and hazards to other road users and pedestrians.
