

# Notice of Variation given under sections 35C and 46A of the Road Traffic Regulation Act 1984 of On-Street Parking Permit Charges in the Colchester City Area

**The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Order 2019 Schedule 4 Permit and Ticket Parking Charges and Schedule 7 On-Street Payment Parking Charges**

NOTICE IS HEREBY GIVEN that the Colchester City Council as the lead authority for The North Essex Parking Partnership, itself acting as agents for the highway authority Essex County Council, intends, not less than twenty one days from the date of this notice, to vary the above Order relating to fees and charges under Section 35C and 46A of the Road Traffic Regulation Act 1984. It is intended that the changes will take place on **21 August 2023**

The variation will have the effect of changing the tariff of fees for On-Street Parking, Exemptions and Permits and On-Street Payment Parking Charges – all other fees and charges in the Order will continue at their existing tariffs. Existing and proposed charges are detailed in the Schedule to this Notice
