

The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.31) Order 202x

Notice is hereby given Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1st July 2022 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

The effect of the Order:

1. To Introduce No Waiting at Any Time restrictions at the junction of Thaxted Road, Rylstone Way and Burnsall Close, Saffron Walden.
2. To introduce restrictions along Walson Way, Halstead between Reeve Road and Church Road. No waiting at Any Time restrictions at the junctions with Herrington Avenue, Palmer Close, Hampton Road and access roads near to 46 and 58 Walson Road. No Waiting at Any Time on the North side between Herrington Ave. and Hampton Road. On both sides at the bend near to Reeve Road. On the East side of the road from Palmers Close to Church Road.
3. To introduce No Waiting 6am – 7pm on the South side of Walson Way from number 74 to 92 Walson Way.

This Order will be incorporated into The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by replacing tile numbers TL545 377, TL510 240, TL515 240 revision 0 replaced by revision 1.

Statement of Reasons

The proposed introduction of No Waiting at Any Time restrictions at the junction of Rylstone Way and Thaxted Road, Saffron Walden is intended to prevent parking close to the junction improving safety for all road users.

The proposed restrictions on Walson Way, Stansted Mountfitchet is necessary to improve access for public transport buses.

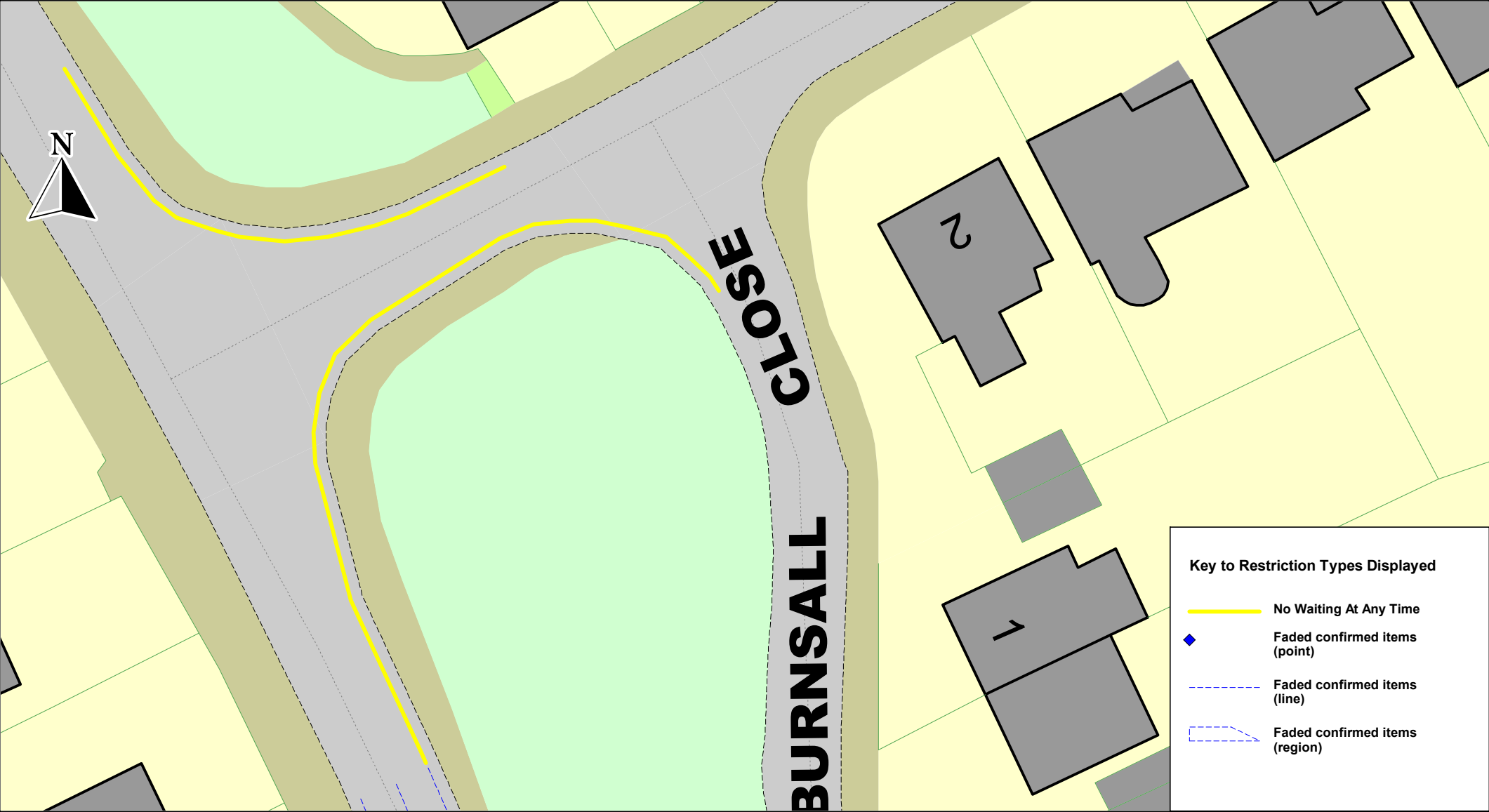
WHEREAS Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1st July 2022 in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-


1. The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.31) Order 202x and shall come into operation on XX XX XX.
2. This Order will be incorporated into The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 'the 2019 Order' by:
 - a. replacing the following Map Tile:

TL545 377 revision 0 replaced by revision 1.
TL510 240 revision 0 replaced by revision 1.
TL515 240 revision 0 replaced by revision 1.
3. The Map Schedule Legend to this Order only applies to the Map Tiles listed in this Order.
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by regulations made or having effect as if made under the Act or by any other enactment.
