

The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.71) Order 202x

Notice is hereby given Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1st July 2022 proposes to make the above Order under Sections 1(1), 2(1) to (3), 4 (1), 4(2), 32, 35,45,46,49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984

The effect of the Order:

1. To Introduce No Stopping at Any Time Red Route restrictions on Anchor Road, Tiptree, at its junctions with Maldon Road, Station Road, Gladstone Road, Coriander Road, Rectory Road, Saffron Way and the access road to numbers 36 to 40 Anchor Road.
2. To introduce No Waiting at Any Time restrictions on Eastwood Drive at and opposite its junction with California Close and at its junction with Aldeburgh Gardens.
3. To introduce No Waiting at Any Time restrictions on Old Heath Road at the entrance to Cannock Mill Rise.
4. To partially revoke a section of No Waiting Mon – Sat 8am – 6pm on Old Heath Road between Cannock Mill Rise and 105 Old Heath Road and replace the section with No Waiting at Any Time.
5. To introduce No Stopping at Any Time Red route on Holt Drive, Colchester, at its junctions with Bober Court, Sexton Close and on the north side of the road between Cherry Tree County Primary School and its junction with the B1025.
6. To introduce No Waiting at Any Time restrictions on Hakewill Way on its east side between Knevett Close and Wallace Road.
7. To introduce No Stopping at Any Time Red route on Oaklands Avenue, Colchester at its junctions with Dugard Avenue, Straight Road and President Road.
8. To Introduce No Waiting at Any Time on Parsons Heath opposite the junction with Churnwood Road.
9. To Revoke the Bus stand 7am to 7pm in Middleborough, Colchester and introduce a Bus Stand Maximum wait 1 hour no return 2 hours.
10. To partially revoke the Goods Vehicle Loading Bay in Church Street Colchester and introduce a Disabled badge holders only 3 hrs stay No return within 2 hrs.

11. To amend The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 to allow the properties detailed in Column 3 of the table in the Schedule 5 to this Notice to be able to purchase permits for the existing zone listed in Column 1 of that table.

This Order will be incorporated into The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by replacing tile numbers TL 890 160, TL890 157, TL895 157, TL895 155, TM005 275, TM010 237, TM005 215, TL960 240 revision 0 replaced by revision 1. Replacing tile number TL990 270 revision 2 replaced by revision 3. Introducing tile numbers TM000 212 and TM005 212. Replace Tile TL990 255 revision 1 with revision 2. Replace Tile TM020 262 revision 0 with revision 1. Replace TL990 250 revision 3 with revision 4.

WHEREAS Colchester City Council acting on behalf of the North Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 1st July 2022 in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.71) Order 202x and shall come into operation on XX XX XX.
2. This Order will be incorporated into The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 ‘the 2019 Order’ by:





The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No. 71) Order 202x.

Statement of Reasons

1. To introduce Red Route Clearway (No stopping At Any Time) restrictions at the junctions of Anchor Road, Tiptree, including both ends of the road. This is proposed to address inappropriate parking near to the junctions to increase accessibility and safety for all road users.
2. To Introduce No Waiting at Any Time restrictions on Eastwood Drive, Colchester junctions with California Close and Aldeburgh Gardens. This is proposed to address inappropriate parking near to the junctions to increase accessibility and safety for all road users.
3. To introduce No Waiting at Any Time restrictions in Old Heath Road, Colchester near to the entrance of Cannock Mill rise, to address inappropriate parking at the entrance to the development and to increase accessibility and safety for all road users.
4. To introduce Red Route Clearway (No Stopping At Any Time) restrictions at the junctions of Holt Drive with Bober Court, Sexton Close and the B1025, and is proposed to address inappropriate parking near to the junctions and to increase accessibility and safety for all road users.
5. To introduce No Waiting at Any Time restrictions on Hakewill Way on its east side between Knevett Close and Wallace Road. This will increase visibility and address inappropriate parking on a section of Highway where site lines are compromised.
6. To introduce No Stopping at Any Time Red route on Oaklands Avenue, Colchester at its junctions with Dugard Avenue, Straight Road and President Road. This is proposed to address inappropriate parking near to the junctions and to increase accessibility and safety for all road users.
7. To allow Businesses situated within the area of King Edward Quay to purchase permits to allow parking within the permit parking area.
8. To introduce No Waiting at Any Time restrictions on Parson Heath opposite the junction with Churnwood Road to ensure that Bus services can safely negotiate the junction.
9. To introduce maximum 1 hour limited waiting for Buses at the Bus stand on Middleborough to prevent Buses from obstructing the Stand for excessive periods of time.
10. The re-introduction of a Disabled Bay in Church Street is necessary for users of the art centre and accessibility of the City centre facilities.






